Hello Carolyn,

I hope you are doing well. Please find attached our memo regarding two former sand and gravel pits that are currently being regraded following their closure. The sites had previously furnished some nesting habitat for two SAR birds (Bank Swallow and Barn Swallow), though the nesting sites for both species were provided and maintained directly by mining activities and structures that could only be present only while the pits were operational.

As the pit lands have now been substantially regraded - and are still subject to ongoing and extensive earthworks to fully flatten the entire area - per their respective closure plans and their management plans (in accordance with the notices of activity filed by the pit operators) the area is unlikely to still provide useful habitat.
