- OBTAIN ALL APPROVALS AND PERMITS FROM THE CITY OF OTTAWA PRIOR TO ANY REMOVAL WORK OR CONSTRUCTION.
  - ALL STORM STRUCTURES AND PIPES WITHIN THE PROPOSED BUILDING AREA TO BE REMOVED AND DISPOSED OF OFF SITE.
  - ALL STORM PIPES OUTSIDE THE BUILDING AREA TO BE ABANDONED PER CITY OF OTTAWA STANDARD DETAIL S11.4.
  - SAW CUT AND KEY GRIND ASPHALT AT ALL ROAD CUTS AND ASPHALT TIE IN POINTS PER CITY OF OTTAWA STANDARD DETAIL R10.
  - EXISTING TREES TO BE MAINTAINED WHERE POSSIBLE. GRADING WITHIN ROOT ZONES TO REMAIN UNDISTURBED. REFER TO LANDSCAPE PLANS (DRAWINGS 120202-L1-L3).
  - ALL MONITORING WELLS SHOULD BE DECOMMISSIONED IN ACCORDANCE WITH ONTARIO REGULATIONS O. REG. 903 BY A QUALIFIED LICENSED WELL TECHNICIAN PRIOR TO CONSTRUCTION.
