Indigenous Engagement

1.0 INDIGENOUS ENGAGEMENT

This document provides a description of the Indigenous engagement practices that were conducted by Stantec Consulting Ltd. (Stantec) during the Stage 2 archaeological assessment of the project. No additional documentation arose from the engagement process.

The Ministry of Citizenship and Multiculturalism (MCM) draft technical bulletin entitled *Engaging Aboriginal Communities in Archaeology* states in Section 1.2 that for archaeological projects in Ontario it is encouraged that Aboriginal communities are engaged during the following:

- 1. Stage 1, when conducting background study;
- 2. Stage 1, when evaluating archaeological potential;
- 3. Stage 2, when assessing a property and determining whether a site should be subject to Stage 3; and
- 4. Stage 3, when making recommendations to excavate or preserve Aboriginal sites.

In consultation with Dream Asset Management, Stantec provided notification of the Stage 2 archaeological assessment to representatives at the Algonquins of Pikwakanagan First Nation (APFN) and Kitigan Zibi (KZ).

1.1 FIELD WORK

Coordination of Indigenous Engagement for the Project was facilitated with P.J. Leroux of APFN and Douglas Odjick of KZ. The Stage 2 archaeological assessment of 665 Albert Street was conducted from September 9 to October 28, 2022 under Project Information Form number P415-0395-2022 issued to Patrick Hoskins, MA of Stantec by the MCM. The field representatives present were active members in the archaeological assessment of the study area. No issues were raised regarding the methods or results of the assessment.
