

EXECUTIVE SUMMARY

Assessment

Paterson Group was retained by Dolyn Construction Ltd. to conduct a Phase I Environmental Site Assessment (ESA) of the property addressed 1485 Upper Canada Street, in the City of Ottawa, Ontario. The purpose of this Phase I ESA was to research the past and current use of the site and study area and to identify any environmental concerns with the potential to have impacted the subject property.

According to the historical research, the subject property was always vacant and used for agricultural purposes. No environmental concerns were identified with respect to the historical use of the subject site.

The surrounding properties within the Phase I Study Area were historically used for agricultural purposes. No environmental concerns were identified with respect to the historical use of the surrounding properties.

Following the historical research, Paterson conducted a site visit and a visual assessment of the properties within the Phase I Study Area. The Phase I Property is currently vacant. No concerns were identified with the current use of the Phase I Property.

The surrounding lands within the vicinity of the subject site are vacant lands or occupied by commercial retail/office buildings. No environmental concerns were identified with respect to the surrounding properties.

Based on the results of the Phase I ESA, in our opinion, a Phase II Environmental Site Assessment is not required for the Phase I Property.



1.0 INTRODUCTION

At the request of Dolyn Construction Ltd., Paterson Group (Paterson) conducted a Phase I-Environmental Site Assessment (Phase I-ESA) for 1485 Upper Canada Street, in the City of Ottawa, Ontario, herein referred to as the Phase I Property. The purpose of this Phase I-ESA was to research the past and current use of the Phase I ESA Property and properties within the Phase I Study Area to identify any potentially contaminating activities (PCAs) that would result in areas of potential environmental concern (APECs) on the Phase I Property.

Paterson was engaged to conduct this Phase I-ESA by Mr. Doug Burnside with Dolyn Construction Ltd. Dolyn Construction Ltd. can be reached at info@dolyn.com.

This report has been prepared specifically and solely for the above noted project which is described herein. It contains all of our findings and results of the environmental conditions at this site.

This Phase I-ESA report has been prepared under the supervision of a Qualified Person, in general accordance with Ontario Regulation (O.Reg.) 153/04, as amended under the Environmental Protection Act, and CSA Z768-01 (reaffirmed 2022). The conclusions presented herein are based on information gathered from a limited historical review and field inspection program. The findings of the Phase I-ESA are based on a review of readily available geological, historical and regulatory information and a cursory review made at the time of the field assessment. The historical research relies on information supplied by others, such as, local, provincial and federal agencies and was limited within the scope-of-work, time and budget of the project herein.

3.0 SCOPE OF INVESTIGATION

The scope of work for this Phase I - Environmental Site Assessment was as follows: ☐ Determine the historical activities on the subject site and study area by conducting a review of readily available records, reports, photographs, plans, mapping, databases, and regulatory agencies; ☐ Investigate the existing conditions present at the Phase I ESA Property and study area by conducting site reconnaissance; ☐ Conduct interviews with persons knowledgeable of current and historic operations on the Phase I ESA Property, and if warranted, neighbouring properties; ☐ Present the results of our findings in a comprehensive report in general accordance with the requirements O.Reg. 153/04 as amended under the Environmental Protection Act and in compliance with the requirements of CSA Z768-01 (reaffirmed 2022): ☐ Provide a preliminary environmental site evaluation based on our findings; ☐ Provide preliminary remediation recommendations and further investigative work if contamination is suspected or encountered.

4.0 RECORDS REVIEW

4.1 General

Phase I-ESA Study Area Determination

A radius of approximately 250 m was determined to be appropriate as a Phase I Study Area for this assignment. Properties outside the 250 m radius are not considered to have impacted the Phase I ESA Property based on their significant separation distance.

First Developed Use Determination

Based on a review of available historical information, the subject site has never been developed, although it was historically used for agriculture.

Fire Insurance Plans

Fire Insurance Plans (FIPs) are not available for the subject site.

City of Ottawa Street Directories

City directories do not exist for the general area of the subject site and neighbouring properties.

4.2 Environmental Source Information

National Pollutant Release Inventory

A search of the National Pollutant Release Inventory (NPRI) was conducted as part of this assessment. No records of any pollutant releases were identified for the subject site or for any properties situated within the Phase I study area.

PCB Waste Storage Site Inventory

A search of the provincial PCB waste storage site inventory was conducted as part of this assessment. No current or former PCB waste storage sites were identified within the Phase I study area.

MECP Coal Gasification Plant Inventory

The Ontario Ministry of Environment, Conservation and Parks document entitled, "Municipal Coal Gasification Plant Site Inventory, 1991" was reviewed as part of this assessment. This document provides a reference to the locations of former plants with respect to the subject site. A review of this document did not identify

any former coal gasification plants located on the subject site or within the Phase I study area.

MECP Waste Disposal Site Inventory

The Ontario Ministry of Environment, Conservation and Parks document entitled, "Waste Disposal Site Inventory in Ontario, 1991" was reviewed as part of this This document includes all recorded active and closed waste disposal sites, industrial manufactured gas plants, and coal tar distillation plants situated in the Province of Ontario. A review of this document did not identify any relevant records pertaining to the subject site or for properties located within the Phase I study area.

MECP Submissions

A request was submitted to the MECP Freedom of Information office for information with respect to reports related to environmental conditions for the subject site. A response from the MECP had not been received prior to the issuance of this report.

MECP Instruments

A request was submitted to the MECP Freedom of Information office for information with respect to certificates of approval, permits to take water, certificates of property use, or any other similar MECP issued instruments for the subject site. A response from the MECP had not been received prior to the issuance of this report.

MECP Incident Reports

A request was submitted to the MECP Freedom of Information office for information with respect to records concerning environmental incidents, orders, offences, spills, discharges of contaminants, or inspections maintained by the MECP for the subject site or neighbouring properties. A response from the MECP had not been received prior to the issuance of this report.

MECP Waste Management Records

A request was submitted to the MECP Freedom of Information office for information with respect to waste management records for the subject site. A response from the MECP had not been received prior to the issuance of this report.

MECP Brownfields Environmental Site Registry

A search of the MECP Brownfields Environmental Site Registry was conducted as part of this assessment. No Records of Site Condition (RSCs) were identified in the database as having been filed for the subject site or surrounding properties within the Phase I study area.

OMNRF Areas of Natural Significance

A search for areas of natural and scientific interest situated within the Phase I study area was conducted electronically on the Ontario Ministry of Natural Resources and Forestry (OMNRF) website. The search did not identify any natural features of areas of natural significance within the Phase I study area.

Technical Standards and Safety Authority (TSSA)

The TSSA Fuels Safety Branch in Toronto was contacted on October 14, 2022 electronically, as part of this assessment, to inquire about current and former underground fuel storage tanks, spills, and historical incidents for the subject site and neighbouring properties.

The response from the TSSA indicated that no records were identified pertaining to the subject site or the neighbouring properties. A copy of the correspondence with the TSSA is included in Appendix 2.

City of Ottawa Historical Land Use Inventory (HLUI) Database

As part of this assessment, a requisition form was submitted to the City of Ottawa to request information from the City's Historical Land Use Inventory (HLUI) database for any environmental records pertaining to the subject site as well as any properties situated within the Phase I study area.

A response from the city was received and indicated that there are no records found for the subject site or surrounding properties. A copy of the submission request has been included in Appendix 2.

City of Ottawa Old Landfill Sites

The document entitled "Old Landfill Management Strategy, Phase I – Identification of Sites, City of Ottawa", was reviewed. No landfill sites were identified within the Phase I study area.



ERIS Database Report

A database report, prepared by ERIS (Environmental Risk Information Services) Ltd., dated October 16, 2022, was acquired and reviewed as part of this assessment. The complete ERIS report has been included in Appendix 2.

□ On-Site Records:

The ERIS report did not identify any relevant records pertaining to the subject site.

□ Off-Site Records:

The off-site records identified are listed for properties which are situated at a significant distance away, or are situated in an inferred down-gradient or cross-gradient orientation with respect to anticipated groundwater flow. As a result, these remaining off-site properties are not considered to pose a potential environmental concern to the subject site.

4.3 Physical Setting Sources

Aerial Photographs

Historical air photos from the National Air Photo Library were reviewed in approximate ten (10) year intervals. Based on the review, the following observations have been made:

1959	The Phase I Property appears to be vacant and used for agricultural purposes at this time. Neighbouring properties appear to be occupied by farmsteads or used for agricultural purposes.
1976	No significant changes have been made to the subject site or surrounding properties.
1991	What appears to be access roads are present on the Phase I Property. Quarry operations are visible further southwest of the subject site. Highway 417 is now visible further south of the subject site.
2002	The Phase I ESA Property remains unchanged from the previous photograph. Quarry operations have expanded on the lands further to the northwest.
2011	The Phase I ESA Property remains unchanged from the previous photograph. Quarry operations can now be seen on the lands further

west of the subject site.

2021

Vegetation appears to have been stripped from the Phase I and surrounding properties. Fill piles appear to have been placed on the northwestern portion of the subject site. Commercial retail/office buildings have been constructed in the general area of the subject site.

Copies of selected aerial photographs reviewed are included in Appendix 1.

Water Bodies

No water bodies are present on the subject site. The nearest named water body with respect to the subject site is the Carp River, located approximately 1.9 km to the northeast.

Physiographic Maps

A physiographic map was reviewed from the Natural Resources Canada – The Atlas of Canada website, as a part of this assessment. According to the publication and mapping information, the subject site is situated within the St. Lawrence Lowlands. According to the description provided: "The lowlands are plain-like areas that were affected by the Pleistocene glaciations and are therefore covered by surficial deposits and other features associated with the ice sheets." The subject site is specifically located within the Central St. Lawrence Lowland area, which is rarely more than 150 m above sea level.

Topographic Maps

Topographic maps were obtained from Natural Resources Canada – The Atlas of Canada website and from the City of Ottawa website. The topographic maps indicate that the regional topography in the general area of the site slopes downward towards the east. Based on the topography, the inferred groundwater flow direction in the area of the Phase I Property is to the east, towards the Carp River. An illustration of the referenced topographic map is presented on Figure 2 – Topographic Map, appended to this report.

Geological Maps

The Geological Survey of Canada website on the Urban Geology of the National Capital Area was consulted as part of this assessment. Based on this information, bedrock in the area of the site consists of Paleozoic interbedded limestone and shale of the Verulam Formation. Overburden soils are shown as offshore marine sediments (clay and silt), with a drift thickness on the order of 15 to 25 m.



Water Well Records

A search of the MECPs website for all drilled well records within a 250 m radius of the subject site was conducted as part of this assessment. The search identified no wells on the subject property or within the Phase I study area.

5.0 INTERVIEWS

Property Owner Representative

Mr. Doug Burnside, with Dolyn Construction Ltd., was contacted by email as part of this assessment. Mr. Burnside mentioned that he was acquainted with the site recently and was unaware of any past use of fuel oil on the property, or any other potential environmental concerns regarding the Phase I Property.

6.0 SITE RECONNAISSANCE

6.1 General Requirements

The site visit was conducted on October 20, 2022 by Mr. Mohammed Ramadan with Paterson's Environmental Department. In addition to the site, the uses of neighbouring properties within the Phase I Study Area were also assessed at the time of the site visit, from publicly accessible areas.

6.2 Site Inspection Observations

Site Description

The subject site is vacant with light vegetation covering the majority of the property. Several piles consisting of crushed stone are present on the western portion of the subject site.

The site and regional topography appear to slope down to the east, in the direction of the Carp River.

Water drainage on the subject site occurs primarily via infiltration throughout the property. No ponded water, stressed vegetation, surficial staining, or any other indications of potential sub-surface contamination were observed on the subject site at time of the site inspection.

A depiction of the subject site is illustrated on Drawing PE5893-1 – Site Plan, in the Figures section of this report.



Potential Environmental Concerns

☐ Fuels and Chemical Storage

No chemical storage areas, above ground storage tanks (ASTs), or signs of underground storage tanks (USTs) were observed on the exterior of the subject site at the time of the site inspection.

☐ Hazardous Materials and Unidentified Substances

No hazardous materials, unidentified substances, spills, surficial staining, abnormal odours, stressed vegetation, or any other indications of potential subsurface contamination were observed on the exterior of the subject site at the time of the site inspection.

☐ Polychlorinated Biphenyls (PCBs) and Transformer Oil

No potential sources of PCBs were identified within the subject site at the time of the site inspection.

□ Waste Management

No waste materials are currently being generated on-site.

☐ Fill Material

Fill material that consists of crushed stone (engineered fill) was placed on the subject site in 2017. This material is not considered to represent a PCA, and therefore it is not considered to be an APEC.

Neighbouring Properties

An inspection of the neighbouring properties was conducted from publicly accessible roadways at the time of the site inspection. Land use adjacent to the subject site is as follows:

North:	Upper Canada Street, followed by a commercial building under constuction;
South:	Campeau Drive, followed by vacant lands;
East:	Vacant lands, followed by Commercial office building;
West:	Upper Canada Street, followed by vacant lands.

The current uses of the adjacent properties are not considered to pose an environmental concern to the subject site. Current land use adjacent to the subject site is illustrated on Drawing PE5893-2 – Surrounding Land Use Plan, appended to this report.

7.0 REVIEW AND EVALUATION OF INFORMATION

7.1 Land Use History

Based on a review of available historical information, the subject site has never been developed, although it was historically used for agriculture.

Potentially Contaminating Activities (PCAs) and Areas of Potential Environmental Concern (APECs)

No potentially contaminating activities were identified on the subject site or surrounding properties.

Contaminants of Potential Concern

No contaminants of potential concern were identified on the subject site.

7.2 Conceptual Site Model

Geological and Hydrogeological Setting

The Geological Survey of Canada website on the Urban Geology of the National Capital Area was consulted as part of this assessment. Based on this information, bedrock in the area of the site consists of Paleozoic interbedded limestone and shale of the Verulam Formation. Overburden soils are shown as offshore marine sediments (clay and silt), with a drift thickness on the order of 15 to 25 m.

Groundwater is anticipated to flow in an eastern direction towards the Carp River.

Water Bodies and Areas of Natural and Scientific Interest

No water bodies are present on the subject site. The nearest named water body with respect to the subject site is the Carp River, located approximately 1.9 km to the northeast.

Drinking Water Wells

A search of the MECPs website for all drilled well records within a 250 m radius of the subject site was conducted as part of this assessment. The search identified no wells on the subject property or within the Phase I study area.



Neighbouring Land Use

The neighbouring lands within the Phase I study area consist of vacant lands and commercial properties. Current land use is shown on Drawing PE5893-2 – Surrounding Land Use Plan, in the Figures section of this report.

Potentially Contaminating Activities and Areas of Potential Environmental Concern

As per Section 7.1, no potentially contaminating activities (PCAs) resulting in areas of potential environmental concern (APECs) were identified with respect to the subject site.

Contaminants of Potential Concern

No contaminants of potential concern were identified on the subject site.

Assessment of Uncertainty and/or Absence of Information

The information available for review as part of the preparation of this Phase I ESA is considered to be sufficient to conclude that there are no PCAs or APECs associated with the subject site. The absence of any PCAs was confirmed by a variety of independent sources, and as such, the conclusions of this report are not affected by uncertainty which may be present with respect to the individual sources.




FIGURE 1 KEY PLAN








FIGURE 2 TOPOGRAPHIC MAP











