EXECUTIVE SUMMARY

Assessment

Paterson Group was retained by Thomas Cavanagh Construction to conduct a Phase I – Environmental Site Assessment (Phase I ESA) for the properties addressed 150 & 170 Akerson Road, in the City of Ottawa, Ontario. The purpose of this Phase I ESA was to research the past and current use of the site and Study Area and to identify any environmental concerns with the potential to have impacted the subject property.

Based on a review of available historical information, the Phase I Property has never been formally developed. The Phase I Property existed as dense treed land, until circa 2007 when the site and the surrounding lands were stripped of native vegetation and topsoil in preparation for the development of the surrounding residential subdivision. No environmental concerns were identified with respect to the historical use of the Phase I Property.

The surrounding lands were historically vacant or used for agricultural purposes until developed for residential purposes circa 2007. No environmental concerns were identified with respect to the historical use of the Phase I Property.

Presently, the Phase I Property is vacant. No environmental concerns were identified with respect to the current use of the Phase I Property.

The surrounding lands within the Phase I Study Area consist predominantly of parkland and residential properties, as well as occasional commercial land. A dry cleaners was identified at 25 Cope Drive, approximately 220 m to the northeast of the Phase I Property. Based on its significant separation distance, this dry cleaners is not considered to pose an environmental concern to the Phase I Property.

Based on the findings of this assessment, it is our opinion that a Phase II – Environmental Site Assessment is not required for the Phase I Property.



1.0 INTRODUCTION

At the request of Thomas Cavanagh Construction, Paterson Group (Paterson) conducted a Phase I – Environmental Site Assessment (Phase I ESA) for 150 & 170 Akerson Road, in the City of Ottawa, Ontario. Henceforth, these properties are considered to comprise the 'Phase I Property'. The purpose of this Phase I ESA was to research the past and current use of the Phase I Property as well as the surrounding Phase I Study Area, and to identify any environmental concerns with the potential to have impacted the Phase I Property.

Paterson was engaged to conduct this Phase I ESA by Mr. John Angelosante, of Thomas Cavanagh Construction. Mr. Angelosante can be contacted via telephone at 613-915-0762.

This report has been prepared specifically and solely for the above noted project which is described herein. It contains all our findings and results of the environmental conditions at this site.

This Phase I ESA report has been prepared in general accordance with Ontario Regulation 153/04, as amended under the Environmental Protection Act, and also complies with the requirements of CSA Z768-01. The conclusions presented herein are based on information gathered from a limited historical review and field inspection program. The findings of the Phase I ESA are based on a review of readily available geological, historical, and regulatory information, as well as a cursory review made at the time of the field assessment. The historical research relies on information supplied by others, such as local, provincial, and federal agencies, and was limited within the scope-of-work, time, and budget of the project herein.

4.0 RECORDS REVIEW

4.1 General

Phase I ESA Study Area Determination

A radius of approximately 250 m was determined to be appropriate as a Phase I Study Area for this assignment. Properties located outside of this 250 m radius are not considered to have had the potential to impact the Phase I Property, based on their significant distances.

First Developed Use Determination

Based on a review of available historical information, the Phase I Property has never been formally developed.

The Phase I Property has historically existed as dense treed land, until circa 2007 when the site and the surrounding lands were stripped of native vegetation and topsoil in preparation for the development of the surrounding residential subdivision.

Fire Insurance Plans

Fire insurance plans (FIPs) are not available for the general area of the Phase I Property.

City of Ottawa Street Directories

City of Ottawa street directories are not available for the immediate vicinity of the Phase I Property.

The majority of the surrounding lands are not listed in the directories, with the exception of some commercial lands along Eagleson Road far to the west of the Phase I Property. A review of these directories did not identify any environmental concerns with respect to the Phase I Property or for any other properties situated within the Phase I Study Area.

4.2 Environmental Source Information

National Pollutant Release Inventory

A search of the National Pollutant Release Inventory (NPRI) was conducted as part of this assessment. No records of any pollutant releases were identified for the Phase I Property or for any properties situated within the Phase I Study Area.



PCB Waste Storage Site Inventory

A search of the national PCB waste storage site inventory was conducted as part of this assessment. No current or former PCB waste storage sites were identified within the Phase I Study Area.

MECP Instruments

A request was submitted to the MECP Freedom of Information office for information with respect to certificates of approval, permits to take water, certificates of property use, or any other similar MECP issued instruments for the Phase I Property. A response from the MECP had not been received prior to the issuance of this report.

MECP Incident Reports

A request was submitted to the MECP Freedom of Information office for information with respect to records concerning environmental incidents, orders, offences, spills, discharges of contaminants, or inspections maintained by the MECP for the Phase I Property or neighbouring properties. A response from the MECP had not been received prior to the issuance of this report.

MECP Waste Management Records

A request was submitted to the MECP Freedom of Information office for information with respect to waste management records for the Phase I Property. A response from the MECP had not been received prior to the issuance of this report.

MECP Submissions

A request was submitted to the MECP Freedom of Information office for information with respect to reports related to environmental conditions for the Phase I Property. A response from the MECP had not been received prior to the issuance of this report.

MECP Brownfields Environmental Site Registry

A search of the MECP Brownfields Environmental Site Registry was conducted as part of this assessment. No Records of Site Condition (RSCs) were identified in the database as having been filed for the Phase I Property or for any other properties situated within the Phase I Study Area.



MECP Coal Gasification Plant Inventory

The Ontario Ministry of Environment, Conservation and Parks document entitled, "Municipal Coal Gasification Plant Site Inventory, 1991" was reviewed as part of this assessment. This document provides a reference to the locations of former plants with respect to the Phase I Property. A review of this document did not identify any former coal gasification plants located on the Phase I Property or within the Phase I Study Area.

MECP Waste Disposal Site Inventory

The Ontario Ministry of Environment, Conservation and Parks document entitled, "Waste Disposal Site Inventory in Ontario, 1991" was reviewed as part of this assessment. This document includes all recorded active and closed waste disposal sites, industrial manufactured gas plants, and coal tar distillation plants situated in the Province of Ontario. A review of this document did not identify any relevant records pertaining to the Phase I Property or for properties located within the Phase I Study Area.

Technical Standards and Safety Authority (TSSA)

The TSSA Fuels Safety Branch in Toronto was contacted electronically, as part of this assessment, to inquire about current and former underground fuel storage tanks, spills, and historical incidents for the Phase I Property and neighbouring properties.

The response from the TSSA indicated that no records were identified pertaining to the Phase I Property or any of the neighbouring properties.

A copy of the correspondence with the TSSA is included in Appendix 2.

OMNRF Areas of Natural and Scientific Interest (ANSI)

A search for areas of natural and scientific interest situated within the Phase I Study Area was conducted electronically vis the Ontario Ministry of Natural Resources and Forestry (OMNRF) website. The search did not identify any natural features of areas of natural significance within the Phase I Study Area.

City of Ottawa Old Landfill Sites

The document prepared by Golder Associates entitled, "Old Landfill Management Strategy, Phase I - Identification of Sites, City of Ottawa", was reviewed as part of this assessment. No former landfill sites were identified within the Phase I Study Area.



City of Ottawa Historical Land Use Inventory (HLUI) Database

As part of this assessment, a requisition form was submitted to the City of Ottawa to request information from the City's Historical Land Use Inventory database for any environmental records pertaining to the Phase I Property as well as any properties situated within the Phase I Study Area.

The response from the City indicated that no records were identified pertaining to the Phase I Property.

Records were returned which identified a dry cleaners at 25 Cope Drive, located approximately 220 m to the northeast of the Phase I Property. Based on its significant separation distance, this dry cleaners is not considered to pose an environmental concern to the Phase I Property.

A copy of the HLUI search results has been included in Appendix 2.

ERIS Database Report

A database report, prepared by ERIS (Environmental Risk Information Services) Ltd., dated October 5, 2021, was acquired and reviewed as part of this assessment. The complete ERIS report has been included in Appendix 2.

□ On-Site Records:

The ERIS report did not identify any environmental records pertaining to the Phase I Property.

□ Off-Site Records:

The ERIS report identified eight records pertaining to properties located within a 250 m radius of the Phase I Property.

All of these records are reported to be environmental compliance approvals given for various municipal and private water and sewage works carried out as part of the development of the residential subdivision to the north of the Phase I Property.

A review of these records did not identify any environmental concerns with respect to the Phase I Property.



4.3 Physical Setting Sources

Aerial Photographs

Historical air photos from the National Air Photo Library and the City of Ottawa Air Photo Website (GeoOttawa) were reviewed in approximate ten year intervals. Based on the review, the following observations have been made:

1951	The Phase I Property and the surrounding lands appear to be vacant, treed, or used for agricultural purposes at this time.
1976	No significant changes are apparent with respect to the Phase I Property or the surrounding lands since the time of the previous photograph.
1991	No significant changes are apparent with respect to the Phase I Property or the surrounding lands since the time of the previous photograph.
2002	No significant changes are apparent with respect to the Phase I Property or the surrounding lands since the time of the previous photograph.
2011	The Phase I Property appears to be stripped of native vegetation and topsoil and is being utilized as an equipment staging area for the construction of residential dwellings on the surrounding lands. Several piles of fill material/excess soil can be seen in the central portion of the Phase I Property. The Monahan Drain and several residential dwellings can be seen to the south of the Phase I Property.
2019	The Phase I Property no longer appears to be utilized for the storage of any construction equipment or materials at this time. The Phase I Property appears to remain vacant, though some

surficial gravel patches can be seen on the western half of the site. Several piles of fill material/excess soil appear to be present on the eastern half of the site. Akerson Road and additional residential dwellings can be seen to the north, east, and west of the Phase I



Geological Maps

The Geological Survey of Canada website on the Urban Geology of the National Capital Area was reviewed as part of this assessment. Based on the available mapping information, the bedrock in the area of the Phase I Property consists of interbedded limestone and dolomite of the Gull River Formation. The surficial geology consists of organic deposits, with an overburden thickness ranging from approximately 10 m to 15 m.

Topographic Maps

A topographic map was reviewed from the Natural Resources Canada – The Atlas of Canada website as part of this assessment. The topographic map indicates that the general elevation of the Phase I Property is approximately 100 m above sea level. The regional topography in the area of the Phase I Property slopes down towards the southeast, in the general direction of the Jock River. An illustration of the referenced topographic map is presented on Figure 2 – Topographic Map, appended to this report.

Physiographic Maps

A physiographic map was reviewed from the Natural Resources Canada – The Atlas of Canada website, as a part of this assessment. According to the publication and mapping information, the Phase I Property is situated within the St. Lawrence Lowlands. According to the description provided: "The lowlands are plain-like areas that were affected by the Pleistocene glaciations and are therefore covered by surficial deposits and other features associated with the ice sheets." The Phase I Property is specifically located within the Central St. Lawrence Lowland area, which is rarely more than 150 m above sea level.

Water Bodies

No water bodies are present on the Phase I Property. The nearest named water body with respect to the Phase I Property is the Monahan Drain, located approximately 40 m to the southwest.

MECP Water Well Records

A search of the MECPs website for all drilled well records within a 250 m radius of the Phase I Property was conducted as part of this assessment. The search identified one well abandonment record, dated 2010, and one domestic drinking water well installation record, dated 1955. Based on the availability of municipal water services, no drinking wells are expected to be currently in use within the Phase I Study Area.



According to the available well records, the overburden stratigraphy in the general area of the Phase I Property consists of brown clay over grey sand. Bedrock, consisting of limestone, was generally encountered at an average depth of approximately 8 m below ground surface. A select number of the aforementioned well records have been included in Appendix 2.

5.0 PERSONAL INTERVIEWS

Mr. John Angelosante, a representative with Thomas Cavanagh Construction, was contacted via email respond to questioning about the environmental history of the Phase I Property.

According to Mr. Angelosante, the Phase I Property has never been formally developed, although it was stripped of native vegetation and topsoil circa 2007 in preparation for the development of the surrounding residential subdivision. Mr. Angelosante stated that the Phase I Property was occasionally utilized as a staging area for various construction equipment as well as a temporary stockpile area for excess soil generated from the development of the surrounding residential subdivision. According to Mr. Angelosante, the majority of the stockpiled soil was later removed from the site circa 2019, and the property levelled, in accordance with City of Ottawa By-Law requirements.

Mr. Angelosante was unaware of any potential environmental concerns pertaining to the Phase I Property.

6.0 SITE RECONNAISSANCE

6.1 General Requirements

A visual inspection of the Phase I Property was conducted on September 29, 2021, between 3:00 PM and 4:00 PM, by Mr. Nick Sullivan from the Environmental Department of Paterson Group. Weather conditions at the time of the site inspection were cloudy, with a temperature of approximately 15°C.

In addition to the Phase I Property, the uses of neighbouring properties within the Phase I Study Area were also assessed at the time of the site inspection.

6.2 Site Inspection Observations

Site Description

The Phase I Property is currently vacant and consists largely of grassy areas with occasional gravel patches.



The site topography is relatively flat, whereas the regional topography appears to slope gently downwards to the south, in the general direction of the Jock River. The Phase I Property is considered to be at or slightly below grade with respect to the adjacent streets and the neighbouring properties.

Water drainage on the Phase I Property occurs primarily via infiltration throughout the site, as well as via surface run-off towards the Monahan Drain to the south.

No ponded water, stressed vegetation, surficial staining, or any other indications of potential sub-surface contamination were observed on the Phase I Property at time of the site inspection.

A depiction of the Phase I Property is illustrated on Drawing PE5468-1 – Site Plan, in the Figures section of this report.

Buildings and Structures

No buildings or structures currently exist on the Phase I Property.

Potential Environmental Concerns

☐ Fuels and Chemical Storage

No chemical storage areas, above ground storage tanks (ASTs), or signs of underground storage tanks (USTs) were observed on the exterior of the Phase I Property at the time of the site inspection.

☐ Hazardous Materials and Unidentified Substances

No hazardous materials, unidentified substances, spills, surficial staining, abnormal odours, stressed vegetation, or any other indications of potential sub-surface contamination were observed on the exterior of the Phase I Property at the time of the site inspection.

☐ Fill Material

According to conversations with the property owners, excess soil generated from the construction of the surrounding residential subdivision was temporarily stockpiled on the Phase I property. The majority of this excess soil material was recently removed from the site approximately 2 years ago, though trace amounts, mostly consisting of sand and gravel, were observed to remain on-site at the time of the site inspection.



Due to its native origins from the local area, as well as the absence of any deleterious substances, this excess soil material is not considered to pose an environmental concern to the Phase I Property.

□ Polychlorinated Biphenyls (PCBs) and Transformer Oil

No electrical transformers or any other potential sources of PCBs were observed on the exterior of the Phase I Property at the time of the site inspection.

■ Waste Management

No waste materials are currently being generated on the Phase I Property.

Neighbouring Properties

A visual inspection of the neighbouring properties was conducted from publicly accessible roadways at the time of the site inspection. Land use adjacent to the Phase I Property was as follows:

North: Akerson Road, followed by residential dwellings;

South: Parkland, followed by the Monahan Drain and residential dwellings;

East: Residential dwellings;

West: Residential dwellings, followed by parkland.

No environmental concerns were identified with respect to the current use of the neighbouring properties.

The neighbouring land use within the Phase I Study Area is shown on Drawing PE5468-2 – Surrounding Land Use Plan, in the Figures section of this report.



7.0 REVIEW AND EVALUATION OF INFORMATION

7.1 Land Use History

Based on a review of available historical information, the Phase I Property has never been formally developed.

Potentially Contaminating Activities (PCAs)

Based on the findings of this Phase I ESA, no potentially contaminating activities (PCAs) were identified within the Phase I Study Area.

Areas of Potential Environmental Concern (APECs)

No areas of potential environmental concern were identified on the Phase I Property.

Contaminants of Potential Concern (CPCs)

No contaminants of potential concern were identified on the Phase I Property.

7.2 Conceptual Site Model

Geological and Hydrogeological Setting

Based on the available mapping information, the bedrock in the area of the Phase I Property consists of interbedded limestone and dolomite of the Gull River Formation. The surficial geology consists of organic deposits, with an overburden thickness ranging from approximately 10 m to 15 m.

Groundwater is anticipated to be encountered within the overburden and flow in a southerly direction towards the Monahan Drain.

Water Bodies and Areas of Natural and Scientific Interest

No water bodies or areas of natural and scientific interest were identified within the Phase I Study Area. The nearest named water body with respect to the Phase I Property is the Monahan Drain, located approximately 40 m to the southwest.

Existing Buildings and Structures

No buildings or structures currently exist on the Phase I Property.



Current and Future Property Use

The Phase I Property is vacant. It is our understanding that the Phase I Property is to be developed with four low-rise residential apartment buildings.

Drinking Water Wells

Based on the availability of municipal water services, no drinking water wells are expected to be present within the Phase I Study Area.

Neighbouring Land Use

The surrounding lands within the Phase I Study Area consist predominantly of parkland and residential properties.

Current land use is shown on Drawing PE5468-2 – Surrounding Land Use Plan, in the Figures section of this report.

Potentially Contaminating Activities and Areas of Potential Environmental Concern

As per Section 7.1 of this report, no potentially contaminating activities (PCAs), were identified within the Phase I Study Area, and as a result, no areas of potential environmental concern (APECs) were identified on the Phase I Property.

Contaminants of Potential Concern

No contaminants of potential concern were identified on the Phase I Property.

Assessment of Uncertainty and/or Absence of Information

The information available for review as part of the preparation of the Phase I ESA is considered to be sufficient to conclude that there are no PCAs or APECs associated with the Phase I Property.

The absence of any PCAs was confirmed by a variety of independent sources, and as such, the conclusions of this report are not affected by uncertainty which may be present with respect to the individual sources.




FIGURE 1 KEY PLAN






FIGURE 2 TOPOGRAPHIC MAP





<u>Map Key:</u> The map key number is assigned according to closest proximity from the project property. Map Key numbers always start at #1. The project property will always have a map key of '1' if records are available. If there is a number in brackets beside the main number, this will indicate the number of records on that specific property. If there is no number in brackets, there is only one record for that property.

The symbol and colour used indicates 'elevation': the red inverted triangle will dictate 'ERIS Sites with Lower Elevation', the yellow triangle will dictate 'ERIS Sites with Higher Elevation' and the orange square will dictate 'ERIS Sites with Same Elevation.'

<u>Unplottables:</u> These are records that could not be mapped due to various reasons, including limited geographic information. These records may or may not be in your study area, and are included as reference.
