EXECUTIVE SUMMARY

Assessment

Paterson Group was retained by the Ottawa Korean Community Church to conduct a Phase I-Environmental Site Assessment (ESA) for the southern portion of the property addressed 3555 Borrisokane Road, in the City of Ottawa, Ontario. The purpose of this Phase I-ESA was to research the past and current use of the Phase I Property and 250m Phase I Study Area, and to identify any environmental concerns with the potential to have impacted the subject land.

According to the historical research and personal interviews, the Phase I Property has never been formally developed and has historically been used for agricultural purposes or existed as vacant land. No concerns were identified with the historical use of the Phase I Property.

Based on available historical information, adjacent and surrounding properties within the Phase I Study Area were primarily used for agricultural purposes. No off-site historical PCAs were identified within the Phase I Study Area.

Following the historical research, a site visit was conducted. The Phase I Property currently exists as vacant/grassed land. No concerns were identified with the current use of the Phase I Property.

The current uses of the adjacent and neighbouring properties within the Phase I Study Area include primarily agricultural with some residential land being developed to the east. No existing off-site PCAs were identified within the Phase I Study Area at the time of the site visit.

Based on the findings of the Phase I ESA, it is our opinion that a Phase II-Environmental Site Assessment is not required for the Phase I Property.

1.0 INTRODUCTION

At the request of the Ottawa Korean Community Church, Paterson Group (Paterson) conducted a Phase I-Environmental Site Assessment (Phase I-ESA) for 3555 Borrisokane Road, in the City of Ottawa, Ontario. The purpose of this Phase I-ESA was to research the past and current use of the Phase I Property and properties within the Phase I Study Area to identify any potentially contaminating activities (PCAs) that would result in areas of potential environmental concern (APECs) on the subject land.

Paterson was engaged to conduct this Phase I-ESA by Mr. David Parker with Parker Architects (acting on behalf of the Ottawa Korean Community Church). Mr. Parker can be reached by telephone at (905)-353-5257.

This report has been prepared specifically and solely for the above noted project which is described herein. It contains all our findings and results of the environmental conditions at this site.

This Phase I-ESA report has been prepared in general accordance with Ontario Regulation (O.Reg.) 153/04, as amended, under the Environmental Protection Act, and CSA Z768-01 (reaffirmed 2022). The conclusions presented herein are based on information gathered from a limited historical review and field inspection program. The findings of the Phase I-ESA are based on a review of readily available geological, historical and regulatory information and a cursory review made at the time of the field assessment. The historical research relies on information supplied by others, such as, local, provincial and federal agencies and was limited within the scope-of-work, time and budget of the project herein.



3.0 SCOPE OF INVESTIGATION

The scope of work for this Phase I – Environmental Site Assessment was as follows:
 Determine the historical activities on the subject site and study area by conducting a review of readily available records, reports, photographs, plans, mapping, databases, and regulatory agencies;
 Investigate the existing conditions present at the subject site and study area by conducting site reconnaissance;
 Conduct interviews with persons knowledgeable of current and historic operations on the subject properties, and if warranted, neighbouring properties;
 Present the results of our findings in a comprehensive report in general accordance with the requirements of O.Reg. 153/04, as amended, under the Environmental Protection Act, and CSA Z768-01 (reaffirmed 2022);
 Provide a preliminary environmental site evaluation based on our findings;
 Provide preliminary remediation recommendations and further investigative work if contamination is suspected or encountered.

4.0 RECORDS REVIEW

4.1 General

Phase I-ESA Study Area Determination

A radius of approximately 250m was determined to be appropriate as a Phase I Study Area for this assignment. Properties outside the 250m radius are not considered to have impacted the subject land, based on their significant distance from the site.

First Developed Use Determination

Based on a review of available historical information, the Phase I Property has never been formally developed.

National Archives

Fire insurance plans (FIPs) and city directories are not available for the area of the Phase I Property or the surrounding lands.

Chain of Title

Given the available information, it was determined that the results of a chain of title search would not contribute to the environmental assessment for the Phase I Property. Therefore, a chain of title search was not completed as part of this assessment.

Plan of Survey

A topographic plan of survey for the Phase I Properly, prepared by Annis, O'Sullivan Vollebekk Limited was reviewed as part of the Phase I ESA. The plan shows the Phase I Property in its current configuration. A copy of the topographic plan of survey is provided in Appendix 1.

Previous Environmental Reports

A review of environmental projects in the area of the Phase I Property completed by Paterson Group did not identify any issues considered to pose a risk to the Phase I Property.

4.2 Environmental Source Information

Environment Canada

A search of the National Pollutant Release Inventory (NPRI) was conducted electronically on October 12, 2022. No records were found in the NPRI database for properties within the Phase I Study Area.

PCB Inventory

A search of provincial PCB waste storage sites was conducted. No PCB waste storage sites were identified within the Phase I Study Area.

Areas of Natural Significance

A search for areas of natural significance and features within the Phase I Study Area was conducted on the website of the Ontario Ministry of Natural Resources (MNR) on October 12, 2022. The search did not reveal any areas of natural significance within the Phase I Study Area.

Ministry of the Environment, Conservation and Parks Freedom of Information Request

A request was submitted to the MECP FOI office for information with respect to reports related to environmental conditions for the properties. At the time of issuing this report, a response had not been received from the MECP. A copy of the response will be forwarded to the client if it contains any pertinent information.

MECP Instruments

A request was submitted to the MECP Freedom of Information (FOI) office for information with respect to certificates of approval, permits to take water, certificates of property use or any other similar MECP issued instruments for the site. At the time of issuing this report, a response had not been received from the MECP. A copy of the response will be forwarded to the client if it contains any pertinent information.

MECP Waste Management Records

A request was submitted to the MECP FOI office for information with respect to waste management records. At the time of issuing this report, a response had not been received from the MECP. A copy of the response will be forwarded to the client if it contains any pertinent information.

MECP Submissions

A request was submitted to the MECP FOI office for information with respect to reports related to environmental conditions for the Phase I Property. At the time of issuing this report, a response had not been received from the MECP. A copy of the response will be forwarded to the client if it contains any pertinent information.

MECP Incident Reports

A request was submitted to the MECP FOI office for information with respect to records concerning environmental incidents, orders, offences, spills, discharges of contaminants, inspections maintained by the MECP the for Phase I Property or neighbouring properties. At the time of issuing this report, a response had not been received from the MECP. A copy of the response will be forwarded to the client if it contains any pertinent information.

MECP Brownfields Environmental Site Registry

A search of the MECP Brownfields Environmental Site Registry (ESR) was conducted as part of this assessment for the site, neighbouring properties and the general area of the site. No record of site condition (RSC) was identified for the Phase I Property or properties within the Phase I Study Area.

MECP Waste Disposal Site Inventory

The Ontario Ministry of Environment document titled "Waste Disposal Site Inventory in Ontario, 1991" was reviewed as part of the historical research. This document includes all recorded active and closed waste disposal sites, industrial manufactured gas plants and coal tar distillation plants in the Province of Ontario. There are no former waste disposal sites listed in this document within the Phase I Study Area.

Technical Standards and Safety Authority (TSSA)

The TSSA, Fuels Safety Branch in Toronto, was contacted electronically on October 12, 2022 to inquire about current and former underground/aboveground storage tanks, spills, and incidents for the subject and neighbouring properties. The TSSA search did not return any records for the Phase I Property or neighbouring properties. A copy of the TSSA correspondence is included in Appendix 2.

City of Ottawa Historical Land Use Inventory (HLUI)

A request for a search of the City of Ottawa's Historical Land Use Inventory (HLUI) database was submitted to the City of Ottawa. A response had not been received at the time of issuing this report. A copy of the search results will be forwarded to the client upon receipt. A copy of the HLUI request form is provided in Appendix 2.

City of Ottawa Landfill Document

The document prepared by Golder Associates entitled "Old Landfill Management Strategy, Phase I - Identification of Sites, City of Ottawa", was reviewed. No former landfills were identified within the Phase I Study Area.

Environmental Risk Information Service (ERIS) Report

An Environmental Risk Information Services (ERIS) report for the Phase I Property and surrounding lands was acquired and reviewed as part of this assessment. It should be noted that the ERIS report includes information that would normally be obtained through the MECP FOI, MECP well records search as well as several other records (i.e., incident reports, waste generators, etc.). The ERIS report did not identify any records for the Phase I Property. The complete ERIS report has been included in Appendix 1.

The ERIS report identified a total of one record for properties within the 250m radius of the Phase I Property. A historical ERIS search (from 2011) was identified for the property addressed 3128 Moodie Drive. The presence of this historical ERIS search is not considered to represent an environmental concern to the Phase I Property.

4.3 Physical Setting Sources

Aerial Photographs

Historical air photos from the National Air Photo Library were reviewed in approximate ten (10) year intervals. Based on the review, the following observations have been made:

1946 (Poor Scale) The Phase I Property and surrounding lands consist of agricultural land.

1956 (Poor Scale) No significant changes are apparent with respect to the

Phase I Property or the surrounding lands.

1976	(City of Ottawa website) No significant changes are apparent with respect to the Phase I Property. Borrisokane Road is present adjacent to the west of the Phase I Property.
1991	(City of Ottawa website) No significant changes are apparent with respect to the Phase I Property.
2002	(City of Ottawa website) No significant changes are apparent with respect to the Phase I Property. Borrisokane Road has been realigned south of the Phase I Property. Highway 416 is present further southwest of the Phase I Property.
2008	(City of Ottawa website) The north portion of the Phase I Property has been stripped of topsoil. The portion of 3555 Borrisokane Road adjacent to the north of the Phase I Property appears to be used as an access road for the pre-development activities further east.
2021	(City of Ottawa website) The Phase I Property consists of vacant land. The portion of 3555 Borrisokane Road adjacent to the north of the Phase I Property has various stockpiled material. Residential development has occurred further to the east and northeast of the Phase I Property.

Laser copies of selected aerial photographs reviewed are included in Appendix 1.

Physiographic Maps

A Physiographic Map was reviewed from the Natural Resources Canada – The Atlas of Canada website. According to this physiographic map, the site is located in the St. Lawrence Lowlands. According to the mapping description provided: "The lowlands are plain-like areas that were all affected by the Pleistocene glaciations and are therefore covered by surficial deposits and other features associated with the ice sheets." The Phase I Property is located in the Central St. Lawrence Lowland, which is generally less than 150 m above sea level.

Topographic Maps

Topographic maps were obtained from Natural Resources Canada – The Atlas of Canada website and from the City of Ottawa website. The topographic maps indicate that the elevation of the Phase I Property is approximately 92 m above sea level. The regional topography in the general area of the Phase I Property slopes down towards the north, in the general direction of the Jock River. An illustration of the referenced topographic map is presented on Figure 2 – Topographic Map, appended to this report.

Geological Maps

The Geological Survey of Canada website on the Urban Geology of the National Capital Area was consulted as part of this assessment. Based on the information from NRCAN, bedrock in the area of the site consists of dolomite of the Oxford Formation. Based on the maps, the surficial geology consists of organic deposits with an overburden thickness ranging from 15 to 25 m.

Water Well Records

A well record search was conducted on October 12, 2022 for all drilled wells within 250m of the Phase I Property. The search did not return any well records for the Phase I Property or properties within the Phase I Study Area.

5.0 INTERVIEWS

Property Owner Representatives

Mr. Inwon Lee, a representative for the Ottawa Korean Community Church, the current owner of the Phase I Property was interviewed via e-mail correspondence as part of this assessment. Mr. Lee indicated that to his knowledge the Phase I Property has never been formally developed and has historically been used for agricultural purposes. Mr. Lee stated that he was unaware of any environmental concerns with regard to the Phase I Property.

The information obtained through the interview with Mr. Lee is considered to be consistent with site information obtained from other sources (aerial photos, ERIS Database Report and site observations) and is considered to be valid.

6.0 SITE RECONNAISSANCE

6.1 General Requirements

A site visit was conducted on October 14, 2022, by Mr. Jeremy Camposarcone with the Environmental Department of Paterson Group. In addition to the site, the uses of neighbouring properties within the Phase I Study Area were assessed at the time of the site visit from publicly accessible areas.

6.2 Specific Observations at the Phase I Property

Buildings and Structures

No buildings or permanent structures are present on the Phase I Property.

Subsurface Structures and Utilities

The Phase I Property is not currently serviced. No subsurface structures were identified at the time of the site visit.

Site Features

The Phase I Property consists of vacant/grassed land. At the time of the site visit, no signs of stressed vegetation, surficial staining or evidence of fill material were noted on the Phase I Property.

No fuels, chemicals, or signs of ASTs or USTs were observed on the exterior of the Phase I Property at the time of the site visit.

The site and regional topography are relatively flat, with site drainage consisting of infiltration and surface runoff toward Borrisokane Road. Groundwater within the Phase I Study Area is generally expected to flow towards the north towards the Jock River.

No underground structures, drains, pits or sumps were observed on the exterior of the Phase I Property at the time of the site visit. No monitoring wells, potable wells or private sewage systems were observed on site, nor are any expected to be present, as the site has never been formally developed.

Site features are presented on Drawing PE5894-1 – Site Plan, provided in the Figures section following the text.

Potential Environmental Concerns

☐ Fuels and Chemical Storage

No aboveground storage tanks (ASTs) or signs of underground storage tanks (USTs) were observed on the exterior of the Phase I Property at the time of the site inspection.

■ Waste Management

No waste is currently generated on the Phase I Property.

☐ Fill Material

Reworked native material was identified on the north portion of the Phase I Property. The presence of the reworked native material is not considered to represent a PCA on the Phase I Property.

No areas of potential environmental concern were identified on the Phase I Property.

Based on the information from NRCAN, bedrock in the area of the site consists of dolomite of the Oxford Formation. Based on the maps, the surficial geology consists of organic deposits with an overburden thickness ranging from 15 to 25 m.

The topographic maps indicate that the regional topography in the general area of the Phase I Property is relatively flat. Groundwater within the Phase I Study Area is generally expected to flow towards the north.

Fill Placement

Reworked native material was identified on the north portion of the Phase I Property. The presence of the reworked native material is not considered to represent a PCA on the Phase I Property.

Water Bodies and Areas of Natural Significance

No areas of natural significance or water bodies were identified on the Phase I Property or within the Phase I Study Area.

Drinking Water Wells

There are no potable water wells on the Phase I Property or within the Phase I Study Area.

Monitoring Wells

No well records were identified for the Phase I Property or the surrounding lands.

Existing Buildings and Structures

No buildings or permanent structures are present on the Phase I Property.

Subsurface Structures and Utilities

The Phase I Property is not currently serviced.

Neighbouring Land Use





TOPOGRAPHIC MAP











<u>Map Key:</u> The map key number is assigned according to closest proximity from the project property. Map Key numbers always start at #1. The project property will always have a map key of '1' if records are available. If there is a number in brackets beside the main number, this will indicate the number of records on that specific property. If there is no number in brackets, there is only one record for that property.

The symbol and colour used indicates 'elevation': the red inverted triangle will dictate 'ERIS Sites with Lower Elevation', the yellow triangle will dictate 'ERIS Sites with Higher Elevation' and the orange square will dictate 'ERIS Sites with Same Elevation.'

<u>Unplottables:</u> These are records that could not be mapped due to various reasons, including limited geographic information. These records may or may not be in your study area, and are included as reference.
