This letter has been prepared to provide an opinion regarding the current conditions of the aforementioned property (the subject site) following the completion of the Phase I – Environmental Site Assessment (Report No. PE5609-REP.01, dated February 7, 2022 [Revised October 3, 2022]) as well as the Excess Soil Quality Assessment (Report PE5609-LET.01, dated January 3, 2023).

A site visit was carried out on the morning of March 24, 2025 by personnel from Paterson's environmental department to assess the existing conditions of the subject site. The inspection confirmed that the subject site remains vacant of any buildings or structures, with no apparent physical changes having been made to the property or the adjacent lands since the time of the 2022 Phase I ESA.

Based on our observations made during the site visit, as well as a review of a more recent aerial photograph from 2024, it is our opinion that the findings and conclusion presented in the 2022 Phase I ESA report remain valid and that no further update to the previous assessments or any further investigative work will be required.
