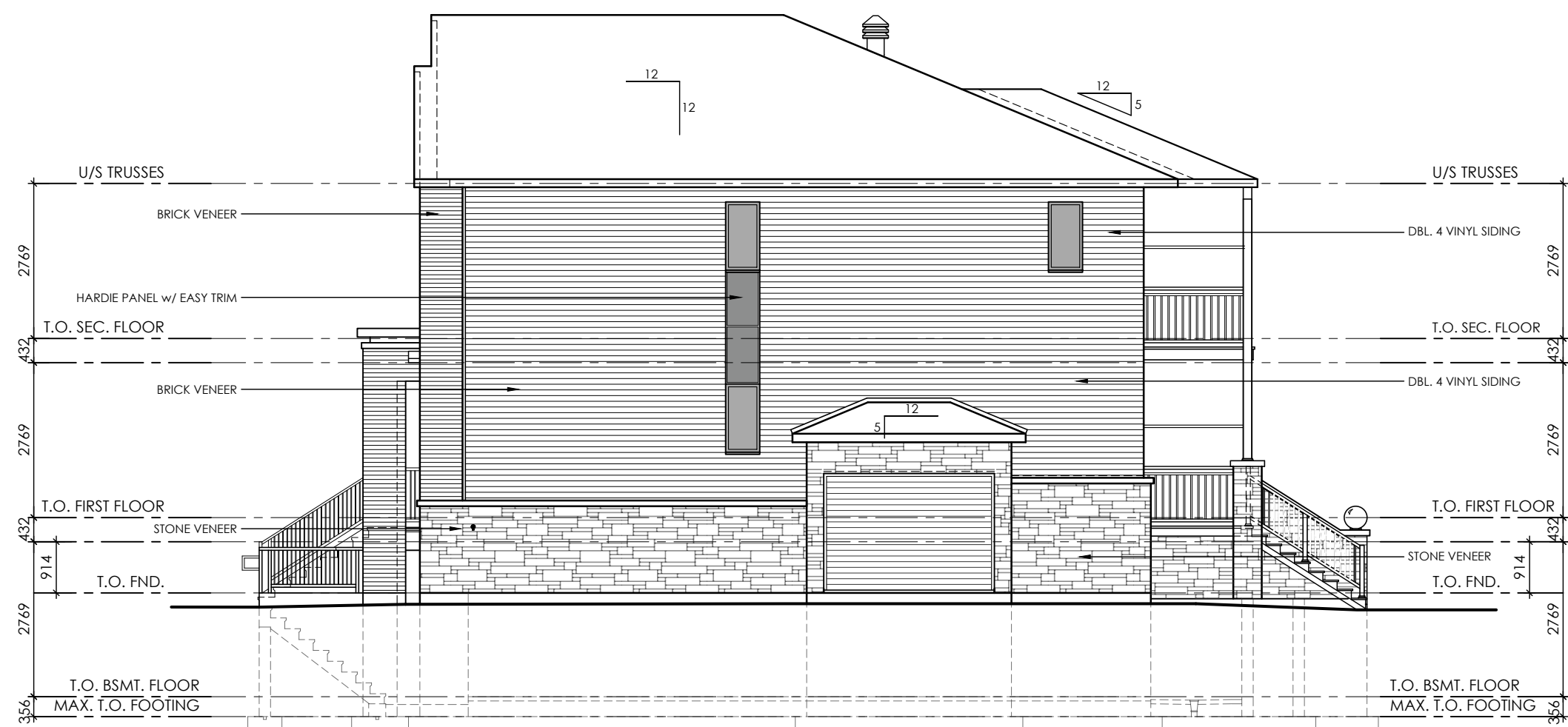




TYPICAL BLOCK - STREET SIDE ELEVATION



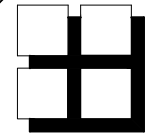
TYPICAL BLOCK - PRIVATE STREET ELEVATION

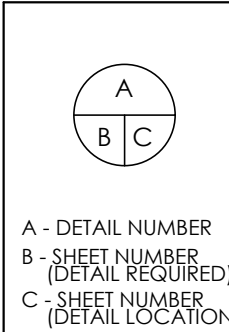

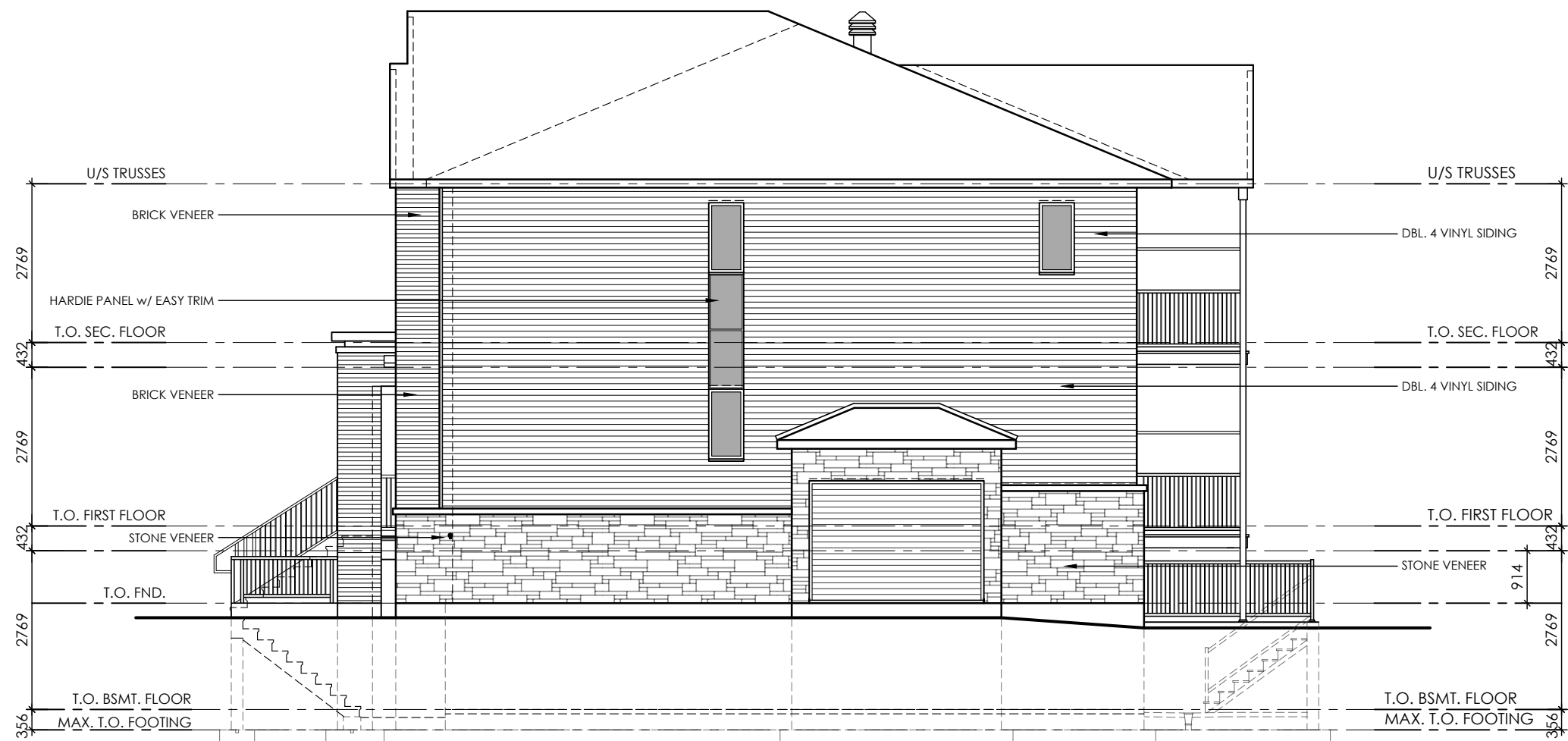

TYPICAL BLOCK - STREET SIDE ELEVATION



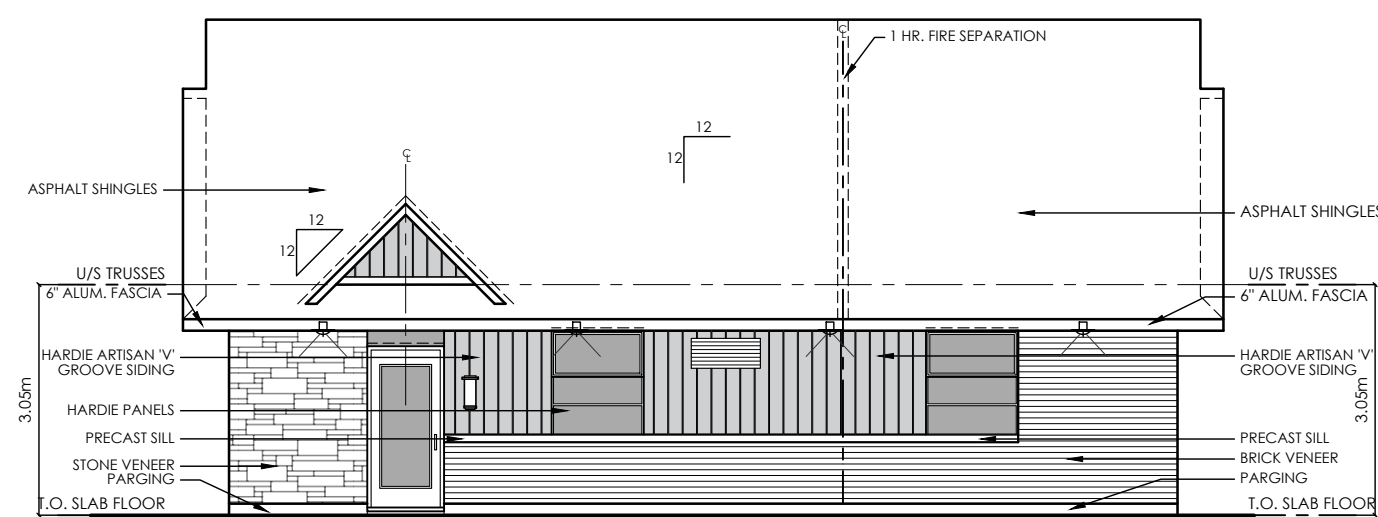
TYPICAL BLOCK - PRIVATE STREET ELEVATION
BLOCKS 3,4 & 6 FRONT ELEVATION



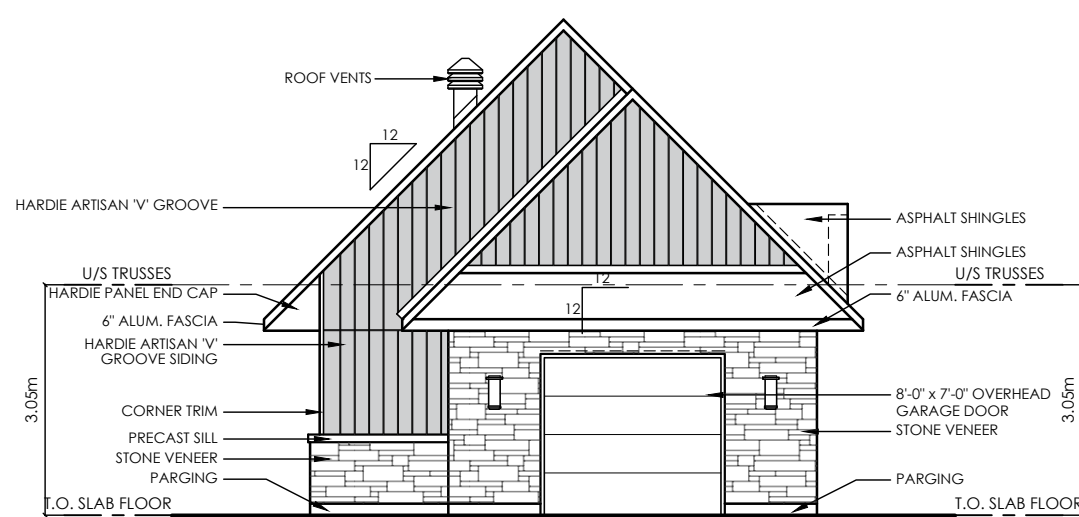
TYPICAL BLOCK - INTERIOR SIDE ELEVATION



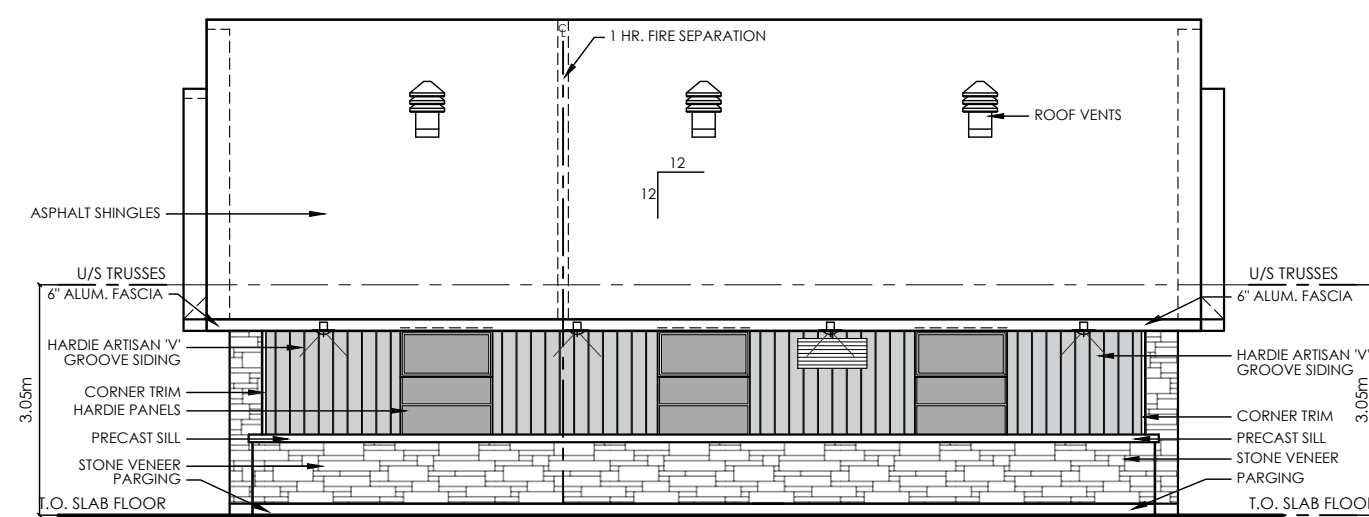
TYPICAL BLOCK - PRIVATE STREET ELEVATION
BLOCKS 3,4 & 6 REAR ELEVATION



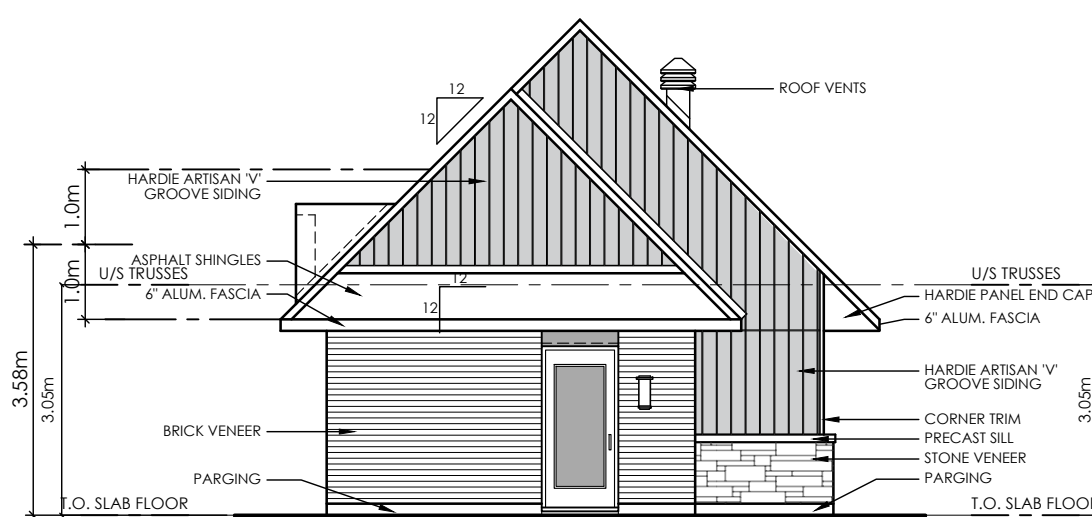
RIGHT SIDE (SOUTH) ELEVATION



FRONT (WEST) ELEVATION

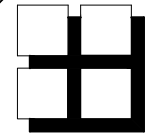


LEFT SIDE (NORTH) ELEVATION
