This letter is to address the preliminary construction management plan for the development at 2505 & 2707 Solandt Road, which is being proposed by Silk Development Group. (Developer).

The Subject Site is located at 2505 & 2707 Solandt Road, Ottawa.

The proposed development area is approximately 4.07 hectares (10.06 acres) and consists of 13 accessory buildings and a main building. Primary access and parking will be located on 2505 Solandt Road. A second construction access is proposed at the southwest corner of 2707 Solandt Road.

#### CONSTRUCTION MANAGEMENT DIAGRAM

During construction, the main site access will be from the existing cul-de-sac at the end of Solandt Road.

No significant interruptions are to be expected.

CONSTRUCTION MANAGEMENT CHECKLIST

1. Will construction require the temporary detour of a bus route?

No bus routes or bus stops will be affected by site development. There are currently no bus stops in operation near the construction site (on Solandt Road).

2. Will this work block a bike lane?

No bike lanes will be affected by the proposed works.

3. Will this work block a sidewalk?

Yes, sidewalks will be affected by the proposed works.

4. Will this work require a lane of traffic to be closed.

There will be isolated lane closures due to service connection construction.

5. Will this work require a road closure?

Work within the boulevard (sidewalk, curb and bus pad) may required some limited lane closures.
