#### **EXECUTIVE SUMMARY**

GEMTEC Consulting Engineers and Scientists Limited (GEMTEC) was retained by Sheldon Creek Developments to complete a Phase One Environmental Site Assessment (ESA) for the proposed residential development on the West Capital Airpark Phase 2B Property in Ottawa, Ontario (the 'Site'). The location of the Site is shown on Figure A.1, Appendix A.

GEMTEC understands that the Phase One ESA is required to determine the potential for soil and groundwater contamination within the Phase One study area of 250 metres around the Site. Given the Site will not be changing to a more sensitive land use (i.e., commercial to residential land use), the filing of a Record of Site Condition (RSC), as regulated by Ontario Regulation (O.Reg.) 153/04 under the Environmental Protection Act, is not mandatory. The Phase One ESA was conducted in general accordance with O.Reg. 153/04, as amended, to support a site plan control application (SPA) with the City of Ottawa.

Based on the results of this Phase One ESA, no areas of potential environmental concern were identified on the Site. As such, a Phase Two ESA is not recommended at this time.

#### **1.0 INTRODUCTION**

GEMTEC Consulting Engineers and Scientists Limited (GEMTEC) was retained by Sheldon Creek Developments. to complete a Phase One Environmental Site Assessment (ESA) for the proposed subdivision development at West Capital Airpark (closer to Albert Boyd Private and Chandelle Private) – Phase 2B in Ottawa, Ontario (hereafter referred to as the 'Site'). The location of the Site is shown on Figure A.1, Appendix A.

It is GEMTEC's understanding that the client plans to develop the Site into a residential subdivision. The proposed subdivision will include multiple residential lots, as well as asphalt surfaced access roads. GEMTEC understands that the Phase One ESA is required to support a site plan control application (SPA) for the Site. Given the Site will not be changing to a more sensitive land use, the filing of a Record of Site Condition (RSC), as regulated by Ontario Regulation (O.Reg.) 153/04 under the Environmental Protection Act, is not mandatory. The Phase One ESA was conducted in general accordance with O.Reg. 153/04.

#### 1.1 Phase One Property Information

The Site currently consists of approximately 20 acres of vacant undeveloped land. The Site is an irregular 'T-shape' consisting of multiple undeveloped residential lots. The Site boundary is shown on Figure A.1 and A.2, Appendix A. The following parcel registers were provided by the client and the respective property identification numbers (PINs) and legal descriptions are summarized below:

Authorization to Proceed with the Phase One ESA was granted via email by Mr. Josh Blokhuis of Sheldon Creek Developments on July 11, 2022.

#### 2.0 SCOPE OF INVESTIGATION

#### 2.1 General Objectives

The general objectives of the Phase One ESA were to:

- Develop a preliminary determination of the likelihood of contamination in soil or groundwater at the Site; and
- Determine the need for a Phase Two ESA.

The general objectives were met though the evaluation of information gathered from records review, interviews, and a Site reconnaissance. Specific objectives for these components and the tasks completed to achieve these objectives are described below.

The qualifications of the persons who completed the Phase One ESA are presented in Appendix B.

#### 2.2 Records Review

The records review was conducted to identify current and past land uses at the Site and within the Phase One study area (i.e., 250 m from the Site boundary) that may have impacted the soil and groundwater quality at the Site. The following available records were reviewed as part of this investigation:



- Bedrock and Overburden Geology Maps Overburden and bedrock geology maps provided by Ontario Basic Mapping, the Ministry of Natural Resources and Forestry, and Environmental Systems Research Institute were reviewed in order to identify the underlying soil deposits and bedrock types;
- City Directories A city directory search was conducted for the Site and adjacent properties using available records in order to review the past and/or present land uses at the Site;
- ERIS Databases The Environmental Risk Information Services (ERIS) searches 73
  public and private information databases to identify potential environmental concerns and
  summarizes the records related to the Site and Phase One study area. An ERIS report
  was obtained for the Site and the Phase One study area;
- Review of available information from regulatory agencies (i.e. Technical Standards and Safety Authority (TSSA), and Local Municipal Works or Engineering Department). These sources can provide information regarding the presence of fuel storage tanks, approvals and permits;
- Aerial Photographs Aerial photographs taken at regular intervals were reviewed for the Site and Phase One study area. The photographs were reviewed in order to identify potential environmental concerns resulting from historical land uses on the Site and within the Phase One study area;
- *"Mapping of Federally Owned Contaminated Sites"* prepared by Treasury Board of Canada Secretariat; and
- *"Ontario Inventory of PCB Storage Sites"*, dated January 1992 and prepared by Ontario Ministry of the Environment (Waste Management Branch).

#### 2.3 Interview

The objective of the interview was to assist in the identification of potentially contaminating activities (PCAs) that may have led to areas of potential environmental concern (APECs) at the Site.

GEMTEC interviewed Mr. Josh Blokhuis, employee of Sheldon Creek Developments. The interview was conducted over the phone on August 2, 2022. Mr. Blokhuis was asked about activities that could have contributed to contamination of soil and groundwater at the Site, and within the Phase One study area.

#### 2.4 Site Reconnaissance

A site reconnaissance was conducted to document current on-site conditions and determine if visually apparent PCAs are present at the Site, which would result in APECs Furthermore,

surrounding land uses within the Phase One study area were assessed to document the presence of PCAs resulting in APECs on the Site.

#### 3.0 RECORDS REVIEW

#### 3.1 General

#### 3.1.1 Previous Environmental Reports

No previous environmental reports were provided to GEMTEC for review as part of this Phase One ESA.

#### 3.1.2 Phase One Study Area Determination

The Site has an area of approximately 8.1 hectares (20.0 acres) and is located to the east of Chandelle Private and to the southwest of the Carp Airport in Ottawa, Ontario.

The Site is presently considered vacant and undeveloped; however, is zoned as an air transportation facility zone (T1B). Future land use of the Site is considered residential.

Based on this information, a study area of 250 m surrounding the Site is deemed sufficient for the purpose of this Phase One ESA. The location of the Site and the extent of the Phase One study area are provided on Figure A.2, Appendix A.

#### 3.1.3 Surficial and Bedrock Geology

Surficial and bedrock geology maps of the Ottawa area were reviewed with Google Earth Pro<sup>™</sup> imagery. Based on the review, overburden in the vicinity of the Site generally consists of coarse textured glaciomarine deposits with sand, gravel, minor silt, and clay with a thickness of approximately 15 to 25 metres (ESRI, 2016). Bedrock is mapped as primarily limestone, dolostone, shale, arkose, and sandstone from the Ottawa and Simcoe Groups of the Shadow Lake Formation (ESRI, 2016).

#### 3.1.4 Topography and Hydrogeology

Topographic mapping available through the Ministry of Natural Resources and Forestry was reviewed to determine topographic features in the vicinity of the Site and Phase One study area.

The elevation of the Site is between approximately 114 and 118 meters above sea level with a regional topography sloping to the north towards the Carp River located approximately 3 kilometers north of the northern extent of the Site (MNRF, 2019).

Regional groundwater flow direction is often influenced by topographic features, and generally flows toward nearby lakes, rivers and wetland areas. Based on the topography and hydrogeological features, it is anticipated that regional shallow groundwater flow would be to the northwest.



#### 3.1.5 Water Bodies and Areas of Natural Significance

A small unnamed creek was identified within the Phase One study area on an Ontario Ministry of Natural Resources and Forestry (MNRF) map. The creek located is directly west of the Site, approximately 150 m, and flows to the north.

Through a review of the Heritage Map website (list website here if not in references) of the MNRF one endangered species, blandings turtle, was identified in a 1 km grid that covers a portion of the Site. No Areas of Natural and Scientific Interest were identified on the Site or within the study area.

#### 3.1.6 First Developed Use Determination

According to a review of available historical aerial photographs, the Site was used for agricultural purposes prior to 1946, followed by vacant undeveloped forested and grassland until at least 2020

#### 3.1.7 City Directories

A search of the City Directories was completed by ERIS for the Site and properties within the Phase One study area by searching a 250 m radius from an address located at the centre of the Site (i.e, 312 Tailslide Private, Ottawa, Ontario). The records were reviewed and no PCAs were identified.

A copy of the City Directory results is provided in Appendix C.

### 3.1.8 Chain of Title

Parcel registers for the Site were provided by the client and respective property identification numbers (PINs) and legal descriptions are summarized below:

A summary of information obtained from the chain of title search with respect to the Site is provided in Table 3.1.

A copy of the chain of titles for the Site can be found in Appendix C.

The Site was purchased from the City of Ottawa by West Capital Developments in 2005. In 2013, West Capital Developments had a change in ownership but continued to own the Site and presently owns the Site. Based on the above noted information, the Site has never been developed and no evidence of PCAs or potential APECs can be inferred based on the ownership information reviewed.



#### 3.2 Environmental Source Information

#### 3.2.1 ERIS Database Report

GEMTEC contacted ERIS to conduct a search of 73 public and private information databases for the Site and the Phase One study area. The complete ERIS report, including a list of the databases searched, is provided in Appendix E.

There was a total of two records pertaining to the Site: one borehole (BORE) record and one water well information system (WWIS) record.

There were two records identified within the Phase One study area (unplottables), both were WWIS records.

No PCAs were identified in the review of the database records compiled in the ERIS report.

#### 3.3 Regulatory Information

#### 3.3.1 Technical Safety and Standards Authority

The TSSA was contacted on July 25, 2022, to conduct a search of properties within the Phase One study. Addresses searched included 1450 and 1451 Diamond view Road, 70 Wingover Private, 44 Sopwith Private, 1500 Thomas Argue Road, and 306 and 322 Tailslide Road, in Ottawa, Ontario.

The TSSA response identified records of expired fuel storage tanks located at 1500 Thomas Argue Road. However, given the distance from the Site, it is unlikely to result in soil and groundwater impacts. A copy of the search request and the response from the TSSA is provided in Appendix F.

#### 3.3.2 Historical Land Use Inventory

A request was made to the City of Ottawa for a search of the Historical Land Use Inventory (HLUI) database on July 28, 2022. The search provides information with respect to properties located within the Phase One study area which are considered to have a potential for environmental impacts. A response to the HLUI request has not yet been received from the City of Ottawa. If the City of Ottawa's response identifies records with respect to the Site which indicate areas of potential environmental concern, the client will be notified, and an update will be provided.

#### 3.3.3 Mapping of Federally owned Contaminated Sites

A Government of Canada Treasury Board of Canada Secretariat, interactive map illustrating a database of over 4,000 federally owned contaminated sites was reviewed. The database did not identify any federally owned contaminated sites within the study area (TBCS, 2021).



#### 3.3.4 Landfills

A Government of Ontario map and website for large landfill sites and small landfill sites was reviewed. The database did not identify any historical or current landfills in the Phase One study area (Large landfill sites map, 2021; Small landfill sites list, 2021).

#### 3.4 Physical Setting Sources

#### 3.4.1 Aerial Photographs

Aerial photographs available from the National Air Photo Library in Ottawa, Ontario (NAPL) were reviewed for 1946 and 1967, and copies are provided in Appendix G. For years where no NAPL photographs were available, photographs from geoOttawa were reviewed for 1976, 1999, 2002, 2008, 2011, 2014, 2017 and 2021. Aerial photographs were reviewed to establish the period progress from initial development at the Site to the present. The aerial photographs were also reviewed to identify any PCAs at the Site and within the Phase One study area which could result in APECs. A summary of the aerial photograph information is provided in Table 3.2.

No PCAs were identified during the aerial photograph review of the Site, or within Phase One Study Area.

#### 3.4.2 Fill Materials

Engineered subgrade material was identified on the northern portion of the Site and is recognized as a potential source of contamination, PCA #30: Importation of Fill Material of Unknown Quality, in accordance with O.Reg. 153/04. However, the material is of known origin - from the local Thomas Cavanagh March Road Quarry.

#### 3.4.3 Well Records

Water well records were reviewed from the Ontario Ministry of the Environment, Conservation and Parks (MECP) for the Site and study area. A total of 4 water wells were identified within the study area. Three of the wells were reported for use as domestic water supply, and one as a test well abandoned due to insufficient supply. A summary of the approximate location of the water wells can be found in Figure A.3.

#### 4.0 INTERVIEW

An interview was conducted the phone with Mr. Josh Blokhuis of Sheldon Creek Developments on August 2, 2022. Mr. Blokhuis is a Project Manager at Sheldon Creek Developments and has been familiar with the Site for approximately 3 years. The following relevant information concerning the Site as a result of the interview was noted below:

- Mr. Blokhuis indicated that the Site is currently zoned as T1B Air Transportation Facility Zone but has existed as vacant undeveloped forested land until the January of 2022 when it was clear cut in preparation for development.
- Mr. Blokhuis indicated that there are no current or historical structures on Site;
- Mr. Blokhuis noted that there are no domestic wells on the Site; water is supplied through a watermain by the City of Ottawa, which is directed to the Carp Airport water treatment facility; and
- Mr. Blokhuis indicated that to the best of his knowledge, there are no current or historical concerns that would result in PCAs or APECs at the Site.

Based on information provided in the interview and Site reconnaissance, one PCAs was identified.

• Item 30. Importation of Fill material of Unknown Quality: A pile of granular engineered subgrade material was observed on the north potion of the Site. The material is of known origin, and a remanent from construction on the Phase 1B property. As a result of the aforementioned information, the identified PCA is not considered and APEC at the Site.

#### 5.0 SITE RECONNAISSANCE

#### 5.1 General Site Conditions

A GEMTEC representative, Ester Wilson, visited the Site and conducted the site reconnaissance on July 28, 2022, between the hours of 1:45 PM and 2:30 PM. The study area was assessed in a systematic manner by walking the Site property boundaries and recording visual and olfactory observations. The weather at the time of the site reconnaissance was overcast and the air temperature was approximately 25°C.

#### 5.2 Site Photographs

Photographs of the Site were taken during the site reconnaissance to document the general condition of the Site. Selected relevant photographs are presented in Appendix H. A discussion of the photographs is provided in Table 5.1.

Adjacent properties were viewed from the Site and publicly accessible boundaries to assess the potential for current land uses in the vicinity to adversely impact the Site. The following adjacent properties were observed:

North: Agricultural land followed by the Carp Airport;

South: Vacant, undeveloped forested land;

East: Vacant, undeveloped forested land; and

West: Residential lots on Albert Boyd Road subdivision.

#### 5.3.1 Storage Tanks

No storage tanks were identified on-site at the time of the site reconnaissance.

#### 5.4 Unidentified Substances

No unidentified substances were identified at the time of the site reconnaissance.

#### 5.5 Odours

No significant odours were identified in and around the Site at the time of site reconnaissance.

#### Water, Wastewater and Storm Water

Several well waterline shut off valves were observed across the Site. A storm water management pond was observed approximately 50 metres north of the Site. Multiple storm manholes and sanitary manholes were observed directly to the west of the Site, along Chandelle Private.

#### 5.6 Pits, Ponds and Lagoons

A shallow pond was observed during the site reconnaissance on the northernmost section of the Site in a local topographic low (Photograph 8, Appendix H).

#### 5.7 Stained Materials and Stressed Vegetation

No stained materials or stressed vegetation was observed at the time of the Site reconnaissance.



#### 5.8 Watercourses, Ditches or Standing Water

Standing water was observed in a storm water management pond directly north of the Site.

#### 5.9 Potentially Contaminating Activities

One PCA was identified during the site reconnaissance visit:

- Item 30: Importation of Fill Material of Unknown Quality
- Fill material was observed on the northern portion of the Site. The material is of known origin, and a remanent from construction on the Phase 1B property. As a result of the aforementioned information, the identified PCA is not considered and APEC at the Site.

#### 6.0 REVIEW AND EVALUATION OF INFORMATION

#### 6.1 Current and Past Uses

The Site is currently vacant and undeveloped and appears to have always existed as such. The land has been recently deforested and is currently covered by clear cut vegetation and grass. There are no buildings or structures currently present on Site. The Site is owned by Sheldon Creek Developments.

#### 6.2 Potentially Contaminating Activities

The Phase One ESA identified 1 PCA on the Site and within the study area, which is summarized in Table 6.1 and identified on Figure A.2 within Appendix A.

### 6.3 Areas of Potential Environmental Concern

No APECs were identified resulting from the on-site PCA identified at the time of this Phase One ESA.

#### 6.4 Phase One Conceptual Site Model

Based on the historical review, interview, and Site reconnaissance, GEMTEC concludes that there were no APECs identified at the Site. Information presented in this report that contributes to the development of the conceptual site model (CSM) is presented as applicable in Figures A.1 and A.3 in Appendix A, and is summarized as follows:

- The Site currently consists of undeveloped vacant forested land.
- A total of 4 water wells were identified within the study area, one of which was on the Site. Ground cover on the Site consists of grass succession on a deforested clear-cut.
- The City of Ottawa services water to the Site from Carp via a watermain. Wastewater is directed to the Carp airport water treatment plant.
- No areas of natural significance were identified within the Phase One study area. Surficial and bedrock geology maps of the Ottawa area were reviewed. Based on the review, overburden in the vicinity of the Site generally consists of coarse textured glaciomarine deposits with sand, gravel, minor silt and clay with a thickness of approximately 15 to 25 metres (ESRI, 2016). Bedrock is mapped as primarily limestone, dolostone, shale, arkose, and sandstone from the Ottawa and Simcoe Groups of the Shadow Lake Formation (ESRI, 2016);
- The Carp River is located approximately 3.0 km north of the Site at an elevation of 91 meter above sea level. Groundwater flow often reflects topographic features and typically flows toward nearby lakes, rivers and wetland areas. One small, unnamed pond is present within the Phase One study area. From review of historical aerial photographs, the pond appears to be man made.
- Based on the topography and hydrogeological features, it is anticipated that local shallow groundwater flow direction is to the northwest;
- Based on the review of records, as well as the site reconnaissance completed as part of this Phase One ESA, GEMTEC identified one PCA at the Site; however, was not considered an APEC at the Site.

Information considered for the development of this Phase One CSM was gathered from numerous sources (i.e. aerial photographs, city directories, environmental database searches, physical setting sources, an interview, and site reconnaissance)

There were no deviations from the Phase One ESA requirements specified in O. Reg. 153/04 nor absence of information that have resulted in uncertainty that would affect the validity of the Phase One CSM.



#### 7.0 CONCLUSIONS AND RECOMMENDATIONS

Based on the records review, interview and Site reconnaissance, no APECs were identified at the Site at the time of this Phase One ESA. As such, a Phase Two ESA is not recommended for the Site.

#### 8.0 LIMITATIONS OF LIABILITY

This Phase One ESA was carried out in general accordance with O.Reg. 153/04, as amended. The results of this Phase One ESA should in no way be construed as a warranty that the Site is free from any and all contaminants other than those noted in this report, nor that all compliance issues have been addressed.
